Chairman's Foreword

As a new season approaches, we need to look back at last season to help plan the future and set our objectives for the next three years. On the field the 'Rovers' were improving, finishing third overall in the Mid-Ulster League. The reserve team lifted the clubs spirits with good cup runs, winning the O'Hara Cup, well done lads.

During the year new dugouts were provided and the car parking area was completed. Also the pitch was sand slit (150 tonnes of sand) and repairs to the pitch completed. Our thanks to "Vancy" for his hard work and dedication. A new training area, external lighting and fencing were added to the clubs facilities. It is planned to complete the Flood lighting in the autumn 2007.

The development of the club still continues, and the committee is in the forefront of bringing the clubs facilities up to the higher standards demanded by the IFA. Only minor improvement to the clubs facilities are required by the IFA inspection committee which leaves us well placed for the 2008/2009 restructuring of the Northern Ireland league

The club committee have laid out plans to start youth football and establish youth teams in the 2007/ 2008 season. This is essential for the long term future of Tandragee Rovers in sustaining the club. A ladies team has been established and we look forward to them joining the women's league in 2008 and creating a pathway for women and girls in sport.

The Club was founded in 1909, and in two years time we will be celebrating our centenary, we intend to hold a number of commemorative events during the first week in August 2009. We welcome suggestions from the local community as to how best to celebrate this event.

The Clubs management committee have set out a continuous educational programme to obtain JUNIOR CLUBMARK which we hope to achieve this incoming year. I would encourage all club members & players to participate in the educational programme to enhance the club's improvement programme especially in coaching youth.

Our thanks go to the local community for continuing to support our lotto and to our sponsors without whom we would have difficulty in surviving. We need the full support of the whole community to achieve our goals.
